October is Domestic Violence Awareness Month from Cheri Carda, RN

Domestic Violence or Intimate Partner Violence (IPV) is a national problem. According to the Centers for Disease Control (CDC) statistics, around 26% of men to 41% of women have experienced stalking, physical violence, and sexual violence from a partner during their lifetime with reported impact in relation to the incidents. Over 53 million men and over 61 million suffer psychological aggression by partners during their lifetime.

This type of violence does not wait untill adulthood. It starts early tivity, and binge drinking. in adolescence with teen dating violence. It does not discriminate based on race or sexual orientation. However, those with greater inequities in

relation to community, work, societal and cultural structures can be at greater risk; especially those that are marginalized.

The CDC reports that I in 5 homicide victims are killed by an intimate partner. The



health effects can be extensive with depression, negative health outcomes, PTSD, • and high risk behaviors, such as, smoking, risky sexual ac-

Individuals are not the only ones that suffer as a result of IPV. There are societal and economic costs related to lost productivity at work, medical services for injuries,

and criminal justice costs, as well as, other costs that the CDC estimates at 3.6 trillion.

We as a society need to implement prevention strategies to combat IPV. These can be:

- Creating protective environments
- Support for survivors
- Teaching of safe and healthy relationship skills
- Strengthening of economic support for families

Private Water Testing from Curis Beaulieu, Environmental Specialist

The MSPHL can test for three different types of bacteria in private water samples. Routine samples are tested for coliform for iron bacteria is available by special request. These methods are found are used as an "indicator American Public Health Association's Standard Methods for the Examination of Water and Wastewater, and comply Missouri Department of Health and Senior Services standards for drinking water.

Coliform bacte-

ria occur naturally in soil, on vegetation, and in surface waters such as lakes or streams. They also can be found in the intestines of and E. coli bacteria. Testing humans and other animals. Majority of the coliform bacteria are not harmful and in the latest edition of the bacteria" in drinking water. If present, contamination of the water has occurred, and other disease causing bacteria may also have gotten into the water supply. with the U.S. environmen- Escherichia coli (E. coli) is tal Protection Agency and a member of the coliform group of bacteria and is found only in humans and warm-blooded animals. E.

coli in the drinking water indicates that it has been recently contaminated with human or animal wastes. Iron bacteria occur naturally in the soil and derive its energy by oxidizing iron, manganese or aluminum. This oxidizing process creates a reddish-brown slime which over time can build up, clogging screens, well pumps, faucets, pipes, tanks etc. Iron bacteria are not harmful, but it does produce an unpleasant taste and odor.

When testing for these bacteria, the MSPHL tests for presence/absence only, not a specific count.
